Dear Parents

We are planning to take Miss Ross' and Miss Mackay's classes on a visit to Nutcombe Chocolate Factory and Shop in Minehead and Dunster on Tuesday 9<sup>th</sup> February. We will be leaving school at 8.45am and returning to school by 3.45pm travelling with Rendalls Coaches.
